#### PROPERTY:

PUT OUT HOME SIDE  
TAKE IN AWAY SIDE

- HOME SIDE LISTED FIRST – FIELDS FIRST AND OCCUPIES 1<sup>st</sup> BASE BENCH
- AWAY SIDE LISTED SECOND – BATS FIRST AND OCCUPIES 3<sup>rd</sup> BASE BENCH
- PRELIMINARY FINALS TO CONSIST OF 75 MINUTES OR 7 INNINGS (WHICHEVER OCCURS FIRST) TIMED GAMES TO BE PLAYED OUT NO NEW INNINGS TO COMMENCE WITHIN 5 MINUTES OF THE 3<sup>rd</sup> OUT
- TEAMS TO RAKE CUT OUTS AFTER EACH GAME
- TEAMS TO RETURN EQUIPMENT TO PROPERTY ROOM.
- IF IN THE EVENT OF A TIE AT THE BOTTOM OF THE 7<sup>th</sup> INNING OR 75 MINUTES, THE TIE BREAK RULE WILL APPLY
- CLUBS TO SUPPLY THEIR OWN MATCH BALLS FOR PRELIMINARY FINALS
- ASSOCIATION TO SUPPLY MATCH BALLS FOR GRAND FINAL ONLY
- IF IN THE EVENT OF A TIE AT THE BOTTOM OF THE 7<sup>th</sup> INNING OR 75 MINUTES, THE TIE BREAK RULE WILL APPLY
- TEAMS CANNOT BORROW PLAYERS FROM OTHER TEAMS**
- PLAYERS MUST HAVE PLAYED 4 GAMES TO QUALIFY FOR FINALS – 3 FOR FIFO WORKERS**
